

Exclaimer Partner Network Terms & Conditions



To join the Exclaimer Partner Network and become a Partner you must fill out the application form located at <http://www.exclaimer.com/resellers/register>.

Exclaimer will review your application within 7 days of receipt and in its sole discretion determine if you are eligible to become an Exclaimer Partner or not. If your application is approved, Exclaimer will send you a confirmation with login details to the Exclaimer Partner Network site.

Exclaimer software order acceptance will take place once your application to join our Partner Program is accepted and our Partner agreement has been completed.

As an Exclaimer Partner, you are expected to:

- Market, display and actively promote Exclaimer software.
 - Make at least one sale per year or conduct an equivalent sales activity.
 - Display the Partner logo on your web site with link.
 - Preserve and enhance the reputation of Exclaimer and the products.
 - Avoid any illegal or unethical actions that could potentially be harmful to Exclaimer and the Exclaimer brand.
 - Conduct and maintain operations in strict compliance with all applicable laws, regulations, and ordinances and never engage in any unfair trade practices.

- The Exclaimer Partner shall at all times comply with Exclaimer's brand guidelines regarding sale and promotion of the products. A copy of the guidelines can be found on the Exclaimer Partner Network.
 - Partner level status can be reviewed regularly with your Account Manager. If the Exclaimer Partner has met the Program requirements, the Exclaimer Partner shall be entitled to renew its current status. If the Exclaimer Partner has not met the Partner Program requirements, it is at Exclaimer's discretion to decide on the appropriate actions.
 - For NFR keys to be renewed on a 12-month basis, you must complete at least one transaction with Exclaimer in the prior one-year period. If at any time you do not meet these purchasing requirements, your NFR keys will be deactivated and you will not be authorized to use those licenses.
 - Partner Program benefits and requirements found on the Exclaimer Partner Network can be amended from time to time. Exclaimer shall always be entitled to change and/or update the benefits and requirements. Such change and/or update will be posted on the main Partner Network site. Exclaimer shall under no circumstances be liable towards the Exclaimer Partner for any changes to its status as an Exclaimer Partner, including any changes in partner status.
 - All benefits, rewards and discounts are issued on an individual Partner basis at the discretion of Exclaimer. These are not to be transferred to another Exclaimer Partner, regardless of the circumstances. This will be seen to be a breach of the Exclaimer Partner Network Agreement. Every approved Exclaimer Partner must deal directly with Exclaimer only.
 - Information regarding Partner Rewards can be found on the Exclaimer Partner Network.
 - The Terms & Conditions may be terminated by either party without cause or incurring liability toward the other party upon 30 days' prior written notice to the other party.
 - These Terms & Conditions shall be governed by the laws of the United Kingdom.
